Fee Refund Policy

1. The \$100 registration fee paid at the beginning of the application process is non-refundable.
2. If a student has paid an amount of the tuition to the Academy, a full refund, less the processing fee (\$500.00), will be allowed if Citizenship and Immigration Canada does not issue the Study visa/permit. To obtain a refund, the student must provide:
 - a. The original Letter of Rejection from Citizenship & Immigration Canada
 - b. The original A+ Academy's Official Letter of Acceptance
 - c. The original receipt of tuition fee payment
3. There will be no refund of the tuition fee after a Study Permit/Student Visa has been granted using the A+ Academy's Official Letter of Acceptance, if the student chooses to withdraw for other reasons.
4. There will be no refund of the tuition fee that has been paid to the Academy once the program has begun.
 - a. If the student wishes to withdraw from the course once the classes have begun, then the student **MUST** pay the full tuition fee regardless of when they withdraw.
5. There will be no refund of the tuition fee if the student is found in violation of school regulations and asked to withdraw from the school.
6. There will be no refund of the tuition fee if the student's immigration status is changed during the course. A student who becomes a Permanent Resident of Canada after tuition fee is paid is not eligible for a refund.
7. In case the student is minor and is granted a visa but, for any reason, the parent visa is refused, there will be 3 options available for the parent.

(International Academy of Language and Culture)

- a. To arrange for a custodian in Canada to look after his son/daughter during the study period. The custodian must be a citizen or landed immigrant in Canada.
- b. To ask the Academy to arrange for the custodian. The terms and conditions and the charges in this regard will be worked out on case to case basis.
- c. To cancel the program of his son/daughter of coming to Canada. In this case, the student's case at the Academy will be treated exactly the same way as the refusal of visa for the student and they will be eligible for full refund (less the administration fee of \$500.00). The student will be required to send us the Academy's original offer letter, original tuition fee payment receipt, original visa refusal of their parent and written request of refund by the student and their parent)
